Guide for Authors

Submissions are required to comply with all laws and enforcement regulations related to ensuring the safety of regenerative medicine, as well as related laws and regulations such as the clinical research law enforcement regulations. Contributors should carefully read the contents indicated at the following URL. (<http://www.jarde.jp/saia.html>)

For studies involving human subjects, please refer first to the Declaration of Helsinki (The Code of Ethics of the World Medical Association, <https://www.wma.net/policies-post/wma-declaration-of-helsinki-ethical-principles-for-medical-research-involving-human-subjects/>; and with the Uniform Requirements for Manuscripts Submitted to Biomedical Journals, <http://www.icmje.org/>. The manuscript should include a statement that informed consent was obtained for experimentation with human subjects. The privacy rights of human subjects must always be observed.

This journal is peer-reviewed open-access online journal in English published by the Japanese Society of Alternative to Animal Experiments (JSAAE). Please read all the contents below carefully before submitting.

1. Submission qualification

All authors including co-author(s) need to be the Japanese Association of Regenerative Dentistry (JARD) members. However, those authorized by the Permanent Council of JARD, the Council of JARD, or the Editorial Committee of JARD shall be treated as exception author(s).

2. Compliance

1) Clinical studies targeting humans, and contents including animal experiments
Informed consent of all subjects of the affiliated institution is necessary. Also, it is necessary for all institutions to approve by the Institutional Ethics Committee. For animal experiments, indicate complete compliance with the institutional guidelines. In addition, it is necessary to post the approval number of the institution.

2) Administration of unapproved medication, or including unapproved medical technology
It is necessary to describe the presence or absence (if applicable) of the provision of funds, chemicals, etc. in the text. In addition, when drugs with potential harms are used, it is necessary to describe the review and approval by the contributor

or the affiliated institution of the coauthor. Also, in this case post an authorization number of the institution.

3) Promise when submitting a paper Check all the items on posting checklist by complaisance. And prepare with a check sheet, a pledge, conflicts of interest by self-report, and all manuscripts submitted.

3. Copyright

All copyrights of manuscripts published in this journal belong to JARD. This article are published principally under the terms of the Creative Commons Attribution License, CC BY-ND 4.0 (<http://creativecommons.org/licenses/by/4.0/>), which allows users to copy, distribute and transmit an article as long as the author is attributed and the work is not modified or adapted in any way.

4. Conflicts of Interest (COI)

Authors must state all sources of funding and any other financial and personal relationships that could potentially bias their work in the manuscript. If any author has involvements that might raise a question of bias, they are required to provide details of such involvements. Failure to reveal all pertinent information could result in the article as a fraudulent submission. The editorial committee preferentially publishes papers that clearly indicate COI.

5. Notes and types of manuscripts

Parts of the manuscript and all charts are limited to those unpublished in other publications. In addition, submit a pledge to the editorial committee. If there is a problem, the author takes full responsibility for the entire author. Types of manuscripts are original paper, review, mini review, and others. 5. Adoption of manuscripts and rigorous peer review 1) The acceptance or rejection of the manuscript is due to very strict review by the editorial committee. In principle, the reviewer should be external peer review. 2) The editorial committee fairly decides according to opinions of experts who are two or more many reviewers. 6. Authorship

Submission of publication implies that it has been approved by all authors, that the all content will be not simultaneously under consideration for publication of other journal. All authors are required to contribute to research and manuscript production. Authors who are not involved in the content at all should not be included. The editorial committee may inquire all authors' contributions to the paper at the time of peer review. The editorial committee may request immediate withdrawal or refusal of acceptance of the author(s).

7. Adoption of manuscripts and rigorous peer review

- 1) The acceptance or rejection of the manuscript is due to very strict review by the editorial committee. In principle, the reviewer should be external peer review.
- 2) The editorial committee fairly decides according to opinions of experts who are two or more many reviewers. In order to obtain a fair and accurate review result, the external reviewer selects from outside the affiliated organization of the author(s).
- 3) For peer review of original article, review and mini review, author(s) can appoint one of reviewer in two or more reviewers.
- 4) If the author(s) can not completely improve the indicated matter by the due date, the editorial committee will automatically refuse to adopt the manuscript.
- 5) The receipt and accept date of the manuscript is describe at the end of each paper.

8. Form of manuscript submission

- 1) Submit a paper and attach E-mail. However, if there is a color photograph requesting accurate color reproduction, it is necessary to immediately mail it to the editorial office after acceptance.
- 2) The text is the introduction, materials and methods, results, discussion, cited references. Results and discussion, conclusions, acknowledgments, etc. can be made by author judgment. In addition, it should be changed by reviewers point out.
- 3) If the contributor requires proof of manuscript publication, a reply envelope stamped with stamps should be mailed to the editorial office.

9. Published price

For the original paper and reviews, the basic fee is 26,800 yen up to page 6, and the excess page is 6,200 yen for every 2 pages. The figure, table, monochrome photograph,

reprint, trace, character photocopy, color imprinting and recombination fee by the author's responsibility shall be borne by the author.

10. Proofreading

Proof by the author is carried out once in an electronic file. At this time, the editorial committee does not allow significant correction of tokens other than errors. If significant corrections are made, corrected articles will be subject to re-review.

11. Other

Contents not stipulated in this provision and the editorial committee decides the guidance for submission separately.

1. Contribution of manuscript

Please submit 1)-4) as an electronic file downloaded from the website.

- 1) Contribution Vote
- 2) Check Sheet (Including agreement on electronic journal)
- 3) Pledge
- 4) Conflicts of interest conflict by self-declaration
- 5) Title, Name(s), Affrication(s), English synopsis (A4 version), English keywords (3-5)
- 6) English papaer (A4 version, 11 point Arial font, paragraph one line)
- 7) Table (All tables are produced in Excel or Word, Image files are prohibited as text can not be obtained)
- 8) Figure (Files: PPT, TIF, JPG, PDF)

If color reproduction requires accurate color reproduction, it is necessary to mail it.

In case of returning photographs and figure charts, If return envelopes in stamped are not mailed, can not return them.

2. Electric file

The character part of the submitted manuscript is unified with MS word of Windows.

Other OS than Windows is not accepted.

When it is assumed that there are problems such as garbled characters please be sure to also send it in PDF format.

Charts including photos are accepted as TIF, JPG (note the compression ratio). PPT and PDF are also possible. PDF is not recommended because poor image quality. Please inquire other file formats.

3. Title

- 1) The title shall properly represent the content of the paper.
- 2) Product names or company names that are not proper names can not be used.
- 3) When a subtitle is required, expressions such as "1 st report", "Part 1" etc are not used.
- 4) When exceeding 30 characters, indicate the running title.

4. Author and affiliation

In case of multiple authorship and different affiliation, 1), 2), 3), ---with superscript after the author name and affiliation. Foreign authors' names and affiliation shall be native language notation.

If special foreign characters are included, it is written in English.

5. Synopsis

In principle, the number of words should be 100 to 150. To be able to grasp the outline of the article including the conclusion.

6. Text

- 1) It is A4 size and one paragraph. The font uses 11 point Arial. Except for special characters, and describe the page number.
- 2) The headings set items in the following order.
 1. → 1) → (1) → a. → a) → (a)The presence or absence of a period is left to the judgment of the author.
- 3) Try to use the International System of Units (SI).
- 4) In principle, it is preferable to use generic name as the product name, drug name, instrument name.
- 5) Enter the manufacturer name and the city name in manufacturer notation. For foreign products, write the country name.

7. References

The references should be grouped in a section at the end of the text in numerical order as they appear in the text and should take the following the Vancouver form:

For journals (All author names are listed., *et al.* cannot be used.)

Authors' surname together with their initials: full title of the article, the abbreviated name

of the journal (as shown in Index Medicus), volume (number): inclusive page numbers, year.

Internet is not recommended from the viewpoint of reliability. Only the official HP will be subject. Write URL. Be sure to mention the date of viewing.

Other's

Bibliographic information (titles, names, affiliation, keywords, Synopsis) is released on the JARD website in principle on the date of publication. Full text PDF file will be released in J-Stage etc. These will be published at the same time as the publication of the paper-based journal for members.
